**RESOLUTION DECLARING THE HIGHEST RATED RESPONSIVE BID (HRRB) AND AWARD OF THE CONTRACT FOR THE NEGOTIATED PROCUREMENT FOR SMALL VALUE PROCUREMENT (SEC. 53.9) FOR THE ENGAGEMENT OF A TRAINING PROVIDER ON COMPLETED STAFF WORK (CSW) FOR SHFC**

WHEREAS, pursuant to Sec. 21.2.1(b) of RA 9184, the Request for Quotation (RFQ)/Request for proposal for this project was published in the SHFC website, PhilG-EPS and SHFC Bulletin Boards for seven (7) calendar days, wherein interested bidders/consultants were requested to submit Curriculum Vitae of the principal/project trainer and its technical staff; List of at least three (3) projects/trainings of the same nature for other GOCCs within the past five (5) years must be attached; DTI/SEC/Mayor's permit; PhilG-eps Registration Certificate and Certificate of compliance to the TOR to the BAC on or before 21 July 2015;

WHEREAS, in response thereto, only four (4) prospective consultants, namely: ACG Human Capital Solutions Corp., Cornerstone Consultancy, Development Bank of the Philippines Services Corporation-Management and Consultancy Inc. (DBPSC-MCI) and Harvest for the World Training and Teambuilding Services submitted their proposals within the period stated;

WHEREAS, Section 2(c) of the Guidelines for Shopping and Small Value Procurement provides that "after the decision to resort to Shopping or Small Value Procurement has been made, the conduct thereof may be delegated to the appropriate bureau, committee, or support unit duly authorized by the Bids and Awards Committee (BAC)";

WHEREAS, per Technical Working Group (TWG) evaluation/recommendation report, applying the Quality-Cost Based Evaluation (QCBE) procedure, said TWG evaluated the technical and financial proposal which would constitute the 70% and 30%, respectively, of their total rating, the passing score being 75, **Development Bank of the Philippines Services Corporation-Management and Consultancy Inc. (DBPSC-MCI)** was declared the Highest Rated Bidder/Consultant (HRB), with results as follow:

(DBPSC-MCI)** obtained the highest score and identified as **Highest Rated Responsive Bid (HRRB)**. NOW THEREFORE, we, the members of the Bids and Awards Committee (BAC) hereby RESOLVES, as it hereby RESOLVE, *to declare the bid/price of Development Bank of the Philippines Services Corporation-Management and Consultancy Inc. (DBPSC-MCI) in the amount of One Hundred Sixty Thousand Pesos (Php160,000.00), inclusive of all taxes to be the Highest Rated Responsive Bid (HRRB) and to recommend the approval of the Contract of Award to Development Bank of the Philippines Services Corporation-Management and Consultancy Inc. (DBPSC-MCI).*


