RESOLUTION RECOMMENDING APPROVAL BY THE PRESIDENT
OF THE SHORT LISTED CONSULTANTS

WHEREAS, the Social Housing Finance Corporation Bids and Awards committee (SHFC-BAC) through its Technical Working Group (TWG) has conducted short listing proceedings on 04 July 2011 for Project No. 2011-01: Procurement of Organizational Development Consulting Services;

WHEREAS, pursuant to Section 24.5.4 Rule VIII of the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the Government Procurement Reform Act, stated among others that the BAC shall recommend the short list of consultants to the Head of the Procuring Entity for consideration and approval;

WHEREAS, four (4) prospective bidders were considered for the Short listing procedure namely: 1. SGV & CO. 2. Price Water House Coopers Financial Advisers, Inc. (PWC) 3. CPRM Consultants, Inc. and 4. BCD Consultancy Services;

WHEREAS, after evaluation by the TWG of the submitted documents of the prospective bidders, the following eligible consultants are hereby recommended for having passed the minimum score/ rating of at least seventy five (75%) percent and ranked accordingly based on the average of the rates given:

1. SGV & Co.	83%	1 st
2. PWC	79%	2 nd
3. CPRM Consultants, Inc.	79%	2 nd
4. BDC Consultancy Services	77%	3 rd

WHEREAS, the Bids and Awards Committee (BAC) in its evaluation and deliberation on the matter, considered all the factual circumstances of the foregoing, and in compliance of the above provisions recommends to the Head of the Procuring Entity the above-mentioned short listed consultants for consideration and approval to participate in the bidding process for consultancy services;

NOW THEREFORE, for and in consideration of the foregoing premises, the BAC RESOLVES, as it hereby RESOLVE, to recommend to the President the approval of the short listed consultants/ bidders to participate in the bidding process for having passed at least seventy five (75%) percent the minimum score/ rating of eligible consultants based on the set of criteria and rating system used by the BAC TWG for short listing.
