

## **SEC. EDUARDO DEL ROSARIO**

### **Chairman of the SHFC Board**

### **Department of Human Settlements and Urban Development**

Secretary Eduardo Del Rosario is 64 years old. He was appointed as the Chairman of the Housing and Urban Development Coordinating Council (HUDCC) on 12 July 2017. With the creation of the Department of Human Settlements and Urban Development (DHSUD) on 14 February 2019, he became the first ever Secretary of the Department. He is the Chairman of the Board of SHFC from 12 July 2017 up to present.

He is a distinguished member of Class '80 of the Philippine Military Academy having finished his Bachelor of Science in Military Science in the said Military School. He then took his Masters Degree in Business Administration in the Ateneo Graduate School of Business in 1992-1994. In 2011-2012, he took his Masters in Public Administration in the Philippine Christian University.
